

Preschool Development Grant Birth through Five

Created as part of the bipartisan Every Student Succeeds Act (ESSA) on December 10, 2015, **the Preschool**Development Grant Birth through Five (PDG B-5) program is a \$250 million competitive federal grant that supports states and territories as they work to improve their existing early childhood systems. The inclusion of PDG B-5 in ESSA marks the first time that Congress has dedicated specific funds to promote high-quality early childhood education in the Elementary and Secondary Education Act (ESEA). PDG B-5 affirms both the importance of early learning in advancing equal access to education and the central role of states in leading early childhood coordination and quality efforts.

EMPOWERING STATES

Administered through the US Department of Health and Human Services in consultation with the Department of Education, PDG B-5 funds will empower states to improve the overall quality and efficiency of their early learning programs and systems.

These grants were designed to:

- Better align existing programs,
- Engage parents and families by maximizing parental choice,
- Build on the success of existing programs through the **dissemination of best practices**,
- Foster increased partnerships among key stakeholders and programs.

Grantees are expected to accomplish these goals through strategic coordination with a broad range of stakeholders.

- In the fall of 2018, 47 states and territories applied for a **one year planning grant**, to be used to:
 - Conduct or update a **needs assessment** to gather data about the current early learning landscape in their state.
 - Use the needs assessment to **create a strategic plan**, which will further promote alignment and partnerships as state leaders enter the implementation phase.
- After completing their year of planning, states will have the opportunity to apply for renewal grants that will fund implementation of their plans for two to four years. The renewal grants will be awarded to a sub-group of initial grantees by December 31, 2019.

46 STATES RECENTLY AWARDED GRANTS

- States have shown tremendous interest in the PDG B-5 program. Governors set a designated state agency and states put forward match of 30%. HHS expected to award a maximum of 40 grants, however 47 jurisdictions applied for PDG B-5 funding. Due to the overwhelming response to the funding opportunity announcement, the Administration for Children and Families (ACF) decided to award as many grants as possible, ultimately awarding grants to 46 states and territories that range from \$538,000 to \$10.6 million. In order to fund the 46 states, the majority of applicants were not fully funded. And 39 states and territories had to revise their scopes of work and received approximately 71% of their original grant award request. HHS has indicated that, due to the overwhelming participation, not all states will receive renewal grants at the program's current funding level. Therefore, increased federal funding of this program is critical to ensure the 46 states and territories awarded planning grants can move forward with implementation.
- ▶ The PDG B-5 represents a unique opportunity for the federal government to build on state investments and initiatives as they consider how to best align and continue to grow their early learning systems.
- Governors from across the country are applauding these critical federal investments, and the comprehensive needs assessments and strategic plans funded in year-one are well underway.
