## **NEW HAMPSHIRE** Solving America's Child Care Crisis

Finding and affording quality child care and early learning options shouldn't be the reason parents choose not to work. Yet for years, the high cost of quality care and the limited supply across the country have created insurmountable challenges for too many families. Before the COVID-19 pandemic, a staggering <u>majority of Americans</u> faced challenges finding quality child care options in their community and affording the care once they found it. Now, as families return to work, they are finding these child care challenges still exist and, in many cases, have only gotten worse - holding back families and New Hampshire's economy. There is no question child care is an integral pillar supporting New Hampshire's economic recovery and that families need a stronger system of care that works.

Of women with at least one child under the age of six, <u>61% reported caretaking</u> as the reason they experienced joblessness.

**New Hampshire Parents Struggle to Find and Afford Quality Child Care.** In New Hampshire, many parents at every income level are unable to enter, return to, or remain in the workforce due to child care challenges, while others are forced to settle for unsafe, low-quality care arrangements they would never otherwise choose for their children, in order to work.

According to data from the Bipartisan Policy Center:

- In <u>New Hampshire</u>, there are 54,020 children under the age of 5 in need of child care, yet only 41,120 child care slots
- Over 24% of kids under 5 in New Hampshire are without the child care they need
- Rural communities in New Hampshire are more underserved than urban communities

Parents in New Hampshire spend an average of <u>\$13,044 for center-based infant care and \$9,524</u> <u>for home-based infant care each year</u>, putting quality child care options out of reach for many families.

Pandemic relief provided by Congress prevented the industry's collapse, but didn't address systematic shortcomings that have plagued families, child care providers, and our economy for years. The existing structure of America's child care market is unsustainable. While most parents can't find or afford quality child care options, child care providers can only charge what families in their area can afford, which often leads to near-poverty wages for early educators and ultimately an untenable business model overall.

According to the Center for the Study of Child Care Employment:

- In 2019, the median wage for child care workers in New Hampshire was \$11.69. For preschool teachers, the median wage was \$14.43.
- New Hampshire early educators with a bachelor's degree are paid 22.5% less than their colleagues in the K-8 system.
- The poverty rate for early educators in New Hampshire is 12.2%, much higher than for New Hampshire workers in general (7.4%) and nearly 8.4 times as high as for K-8 teachers (1.5%).

## Voters View This as a Priority, and <u>Polling Shows Overwhelming Bipartisan Support</u> for Congressional Action to Address the Child Care and Early Learning Crisis:

- 78% of Republicans, 83% of Independents, and 93% of Democrats support making child care
  more affordable by providing financial support to help working families pay some or all of the
  cost of quality care.
- 73% of Republicans, 84% of Independents, and 95% of Democrats support making preschool more available by providing it to all three- and four-year-olds whose parents want to send them.
- 79% of Republicans, 83% of Independents, and 93% of Democrats support making child care more affordable by providing all working parents, regardless of how much they pay in federal income taxes, with a tax credit to help pay for child care.

## Congress Can Help New Hampshire Families Facing Child Care Crisis:

- Ensure families have access to high-quality, affordable child care and early learning programs that is available when and where they need it, regardless of where they live, by investing in a mixed-delivery birth through five system
- Build the supply by making smart investments in the physical infrastructure of child care facilities
- Invest in the child care workforce to expand access to quality
- Continue tax credits to support families' inability to pay for quality care

Using data from Child Care Aware of America on the average cost of center-based care in each state for one infant and <u>new research from the Center for Law and Social Policy</u>, <u>new analysis from FFYF</u> shows how much the average family earning 100% of state median income would save on child care costs each year under the <u>Build Back Better Act</u>.
