

State Of Play



- What Are "Appropriations"?

Congress holds the "power of the purse."

"Appropriations" is the process by which Congress allocates funding for federal programs.

Congress produces 12 separate appropriations bills, each determined by a specific subcommittee which oversees budgeting for individual agencies.

Child care and early learning bills are primarily funded through the Labor-Health and Human Services-Education and Related Agencies bill (often called "Labor-H").

-The Programs





Child Care Development Block Grants:

Provides funding for states to subsidize child care for lower income families.



Head Start: Provides early learning, nutrition, medical care and family services for children in poverty.



Preschool Development Grants B-5: Funding for data, infrastructure, and more efficient programs.

How Appropriations Works: 2025

NOW: White House budget "wish list".

MAY 16: Members of Congress submit "Dear Colleague" letters with priorities

SUMMER: Appropriators decide program-by-program funding levels.

SEPT 30: House and Senate Appropriators resolve differences and pass a budget.



What it is What's at stake



CCDBG: Nutshell



Funding from the Department of Health and Human Services is provided to states as a block grant.



States use funds to provide families with low incomes with child care, through vouchers, subsidies, or paid slots. (They also invest in quality and safety.)


Families that do not receive subsidies pay significantly higher costs. For instances, the price of center-based care ranges from:



The Need

CHILD CARE AND DEVELOPMENT BLOCK GRANT

AT CURRENT FUNDING LEVELS, CCDBG IS ABLE TO SERVE 13% OF ELIGIBLE CHILDREN BIRTH THROUGH 5



The Ask

Child Care and Development Block Grant (CCDBG) – At least an additional \$3.65 billion for CCDBG (a total of at least \$12.4 billion).

IDEA – At least \$974.8 million for grants for infants and families and \$683.5 million for preschool grants.

Head Start



What it is What's at stake

Head Start: Nutshell

WHO: Services to pregnant women & young children (birth to five) who come from families living below the poverty line or are experiencing homelessness, and children in foster care.

HOW: The U.S. Department of Health and Human Services funds community-based, faith-based, and for-profit organizations in a community.

WHAT: Programs collaborate with parents to shape curriculum and allocate resources in ways that best meet the unique local needs of the children, families, and communities they serve.

WHERE: Head Start is located in every Congressional district.

The Impact

Head Start provides children from eligible families with high-quality early learning as well as medical, dental, vision, behavioral, health, and nutrition services.


40 MILLION: Children and their families who have benefitted from Head Start since it was founded 60 years ago.

750,000+: The number of funded Head Start slots across the country.


435: Number of Congressional districts with a Head Start program. (Spoiler: That's all of them!)

The Support


Support for Head Start is strong across the political spectrum. Four out of five (79%) voters say they support Head Start, including:







76% of Independents



86% of Democrats

The Ask

Stand For Head Start – Reject any attempts to weaken or eliminate this important program.

Funding – An additional \$1.94 billion for Head Start (a total of at least \$14.91 billion).

Preschool Development Grants B-5


The Preschool Development Grant Birth through Five (PDG B-5) supports states' ability to build an effective early learning infrastructure.

These competitive federal grants:

- •Help states improve quality and safety across child care programs.
- •Improve state collaboration across multiple child care and early learning programs, systems, and agencies.
- •Assist states in collecting data, so they can make programs work more effectively and efficiently.


