

What It All Means

WHAT IT MEANS

Work on multiple fronts, on offense and on defense.

Follow a "Yes, and..." and "All Of The Above" strategy.

Seize all opportunities to provide more support for families with young children.

Protect programs and policies from elimination or cuts.

WHAT IT DOESN'T

Wins in one area will not mean we've "solved" child care – we still need stronger funding, policies across the board.

Appropriations is a separate opportunity, distinct from the recent reconciliation (OBBB) bill.

We are keeping an eye on the Administration, HHS, and state activity, but this August is focused on Congress and what Members can do.

In A Nutshell

- It's a struggle for millions of hard-working American families to **find and afford** the quality child care they need.
- Robust federal funding for early learning and care programs is essential.
- Congress is currently making decisions on funding through the Appropriations process.
- They are also at home through August to connect with constituents, making this the prime time to get them focused on child care.
- It is important to build support for these programs by urging Members of Congress to **protect and prioritize funding** for child care and early learning programs.


How Appropriations Works: 2025

NOW-SEPT 30: House and Senate write Appropriations bills, making decisions on how much funding programs will have.

SEPT 30: House and Senate vote and either a) pass the FY2026 budget OR b) pass a "Continuing Resolution" through the end of the year (December 2025).

DECEMBER: If still needed, the House and Senate vote and either a) pass a spending bill to fund programs through 2026 OR b) pass a "Continuing Resolution" through a later date.

The Programs



Child Care and Development Block Grants: Provides funding for states to subsidize child care for lower income families.

Head Start: Provides early learning, nutrition, medical care and family services for children in poverty.

PDG B-5: Grants help states become more efficient and effective in coordinating programs and collecting data.

IDEA Parts B and C: Early intervention, special education, and related services for children with disabilities.


CCAMPIS: On-campus child care services for students.


CCAoA Poll Full Data



Overall support for increased funding for child care/early learning




Parents in small town communities support increased funding.

Every year, members sign "Dear Colleague" letters showing support for funding.

For FY2026, **285 Members of Congress** called for increased funding for federal early childhood education and care programs including **238 Democrats** and **47 Republicans**.





Set It Up – Reinforce The Ask

WHO: Hello! My name is Christy and I'm a constituent from Bangor.

CLOSE: I'm happy to work with you on dates and times that could work. Thank you!

In The Meeting



Keep it short! Really short.

Be patient and flexible. You may meet with Members; you may also meet with staffers (who are key to getting things done!)

Make it local. Make it personal. You're the expert in what you know and how this issue has an impact in your state.

Invite them to see a program in person. The best way to engage Members and Staff is to make it interactive!

And remember to make the ask! Protect and prioritize funding for child care and early learning in the FY2026 spending package!

Tactics That Work



Site Visits



Invite members to tour a local child care center or Head Start.

Set up time to talk to teachers, providers, parents.

Highlight all the great stuff your program is doing...and how more funding would help do more great stuff!

Roundtables



Invite Members and staffers to learn more about child care and early learning in your town by attending a roundtable.

Gather employers, parents, providers, educators and/or reporters to talk about child care in your community.

Media



Share your voice through Letters to the Editor or Op-Eds in your local paper.

Make sure to note Members by name, such "And I urge Rep. XX to protect and prioritize funding for child care programs in the FY26 budget."

Check in with local bloggers, reporters, and podcasts on this topic.
